The above mentioned school building has been inspected by the Sub Divisional Engineer, Provincial Sub Division No.2, PWD B&R Br., Faridabad along with concerned JE in charge on dated 29.06.2021. Following are the points which have been observed during the inspection:-

GROUND FLOOR:-

➤ At ground floor there are 13 nos. Classrooms, 02 no. Girls toiletStaff room, 02 no. Boys toilet, 03 no. Activity room, 01 no. Store Room, 05 No. Staff toilet, 01 no. library

FIRST FLOOR:-

➤ At first floor level there are 15 no. Classrooms, 02 no. Girls toilet, 02 no. Boys toilet, 03 no. Activity Room, 04 no. Store room, 04 no. Staff toilet, 05 no. Labs.

SECOND FLOOR:-

➤ At second floor there are 27 no. Classrooms, 02 no. Girls toilet, 02 no. Boys toilet, 01 no. Activity room, 03 no. Store room, 04 no. Staff toilet.

THIRD FLOOR:-

➤ At third floor there are 30 no. Classrooms, 02 no. Girls toilet, 02 no. Boys toilet, 03 no. Store Room, 04 no. Staff toilet.

The building is constructed with frame structure having RCC column, beams slab and 9" thick load bearing outer walls. The structure stability certificate has been also enclosed, which issued by Kamal K Sabharwal, M46054,175, Pkt-E, Mayur Vihar-II Delhi. The fire NOC has also been issued to the concern school from Director Haryana, Fire Service, Panchkula, memo no. DFS/FA/2016/456 dated 04.11.2016. The Hygiene

Certificate is also issued O/o Civil Surgeon, Faridabad vide letter No.SHC/2021/121 dated 23.06.2021. Keeping in view all the circumstance the building of Aravali International School, Sector-85, District Faridabad is seems to be safe and this office has no objection to give safety certificate with validity of one year. Periodical inspection must be insured.
